- ♦ The Board was asked to consider approval of WVWD Resolution No. 03-14-605, amending Resolution No. 09-03-452, "Establishing Charges for the Reproduction of District Public Records," to reflect the costs incurred in responding to such requests. Upon reviewing the proposed changes, Mr. Teuber noted an error in Sections 3(a) and 3(b) of the draft resolution and indicated that the reproduction of a document consisting of one or more pages may be reproduced on paper no larger than 11" x 17", and not 8 ½" x 17" as incorrectly stated on the resolution.
